RESOLUTION  
OF THE  
GOVERNING BODY  
OF THE  
THREE AFFILIATED TRIBES  
OF THE  
FORT BERTHOLD INDIAN RESERVATION

WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and

WHEREAS, The Constitution of the Three Affiliated Tribes generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefits of the Tribes and of the enrolled members thereof; and

WHEREAS, The Natural Resources Committee has approved the exchange of lands between the Three Affiliated Tribes and Helen Shepherd, and rescinds resolution 86-187-C in its entirety, under the terms and conditions stated below; and

NOW THEREFORE, BE IT RESOLVED, That the Tribal Business Council approves the exchange of lands, exclusive of minerals, held in trust by the United States of America for the Three Affiliated Tribes and lands held in trust by the United States of America for Helen Shepherd, 301-A1722, under terms and conditions as stated below and hereby authorized the Chairman of the Tribal Business Council, its Secretary, and Superintendent of the Fort Berthold Agency, the Area Director, and the Commissioner of Indian Affairs to prepare all documents and to do all things necessary to exchange lands for which title is to be transferred to the Tribe and Helen Shepherd under the terms and condition as stated below:

1722 E1/2 17-148-93 containing 320 acres, more or less, valued at \$25,600.00 in exchanging for

Tribal Land

T225A-A, T225A-B SE1/4 3-148-90 containing 160 acres, more or less, valued at \$16,500.00 and

465A Lots 3 & 4, S1/2NW1/4, SW1/4 3-148-90 containing 295.69 acres, an undivided 7/25 interest, containing 28 acres more or less, valued at \$9,100.00
