- WHEREAS, Article VI, Section 5(d) of the Constitution of the Three Affiliated Tribes specifically authorizes and empowers the Tribal Business Council to negotiate with agencies of the United States Government on behalf of the Three Affiliated Tribes; and
- WHEREAS, The Administration For Native Americans has invited the Three Affiliated Tribes under Program Announcement 13.612-911 to submit a competitive Application; and
- WHEREAS, The Three Affiliated Tribes have utilized past ANA Financial Assistance to fund an on-going comprehensive improvement process which is leading to improve Tribal Government capabilities, greater self-sufficiency, and greater self-determination; and
- WHEREAS, The Tribal Business Council must make certain assurances in compliance with Department of Health and Human Services & Administration for Native American regulations;
- NOW, THEREFORE, BE IT RESOLVED, That the Tribal Business Council of the Three Affiliated Tribes hereby authorizes the execution and filing of the attached Program Announcement 13.612-911 Grant Application For Financial Assistance from the Administration For Native Americans for the ANA Grant Period of April 1, 1991 Through March 31, 1992, including all understandings, certifications, and assurances contained in the Application.
