# RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD RESERVATION

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act and
- WHEREAS, The Constitution of the Three Affiliated Tribes generally authorized and empowers the Tribal Business Council to engage in activities on behalf of and in the in the interest of the welfare and benefit of the Tribes and Tribal members; and
- WHEREAS, The Three Affiliated Tribes is experiencing a severe problem with alcohol/drug abuse amongst our people on the Fort Berthold Reservation; and
- WHEREAS, The Three Affiliated Tribes, Tribal Business Council inconjunction with the North Dakota Indian Affairs Commmission Office, Bismarck, North Dakota urges the State Legislature to support the House Bill 1007 for Sixty Thousand Dollars (\$60,000.), the benefit and welfare of the "YOUTH", on the Fort Berthold Reservation; and
- WHEREAS, The Growth and Development Seervices program has been established as the Native American Alcohol/Drug Prevention Education Agency for the Three Affiliated Tribes; and
- WHEREAS, The Growth and Development Seervices program prepares children of the Three Affiliated Tribes (particularily, from disadvantaged families), for lifelong benefits including decision making for the most appropriate life choices, ie., finishing school, college, career options, marriage; and
- WHEREAS, The current resident Native population is estimated to be three thousand six hundred (3,600), persons and a portion of this amount are our youth located on the six (6) segments of the Reservation; and
- WHEREAS, Our children are this Nation's number one (1) priority.
- NOW, THEREEFORE BE IT RESOLVED, that the Tribal Business Council in the best interest of its youth request that the Senate Bill 1007 be appropriated to the North Dakota Indian Affairs Commission Office for the benefit and welfare of our people.

Meals & one nights lodging will be paid and they are personally inviting the Tribal Chairman to come and take part.
