- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and
- WHEREAS, The Constitution of the Three Affiliated Tribes generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS, The Three Affiliated Tribes has identified repair items for immediate consideration with assistance requested from the Bureau of Indian Affairs; and
- WHEREAS, The Contracting Officer of the Bureau of Indian Affairs at the Aberdeen Area Office has issued a Memorandum concerning replacement of doors and hardware on Building #215 and an exit light on Building #236; and
- WHEREAS, The Area Contracting Officer will make available \$45,000 under the options of (1) BIA Advertisement and Award of a Contract or (2) A Tribal Governing Board Contract with the Bureau of Indian Affairs under Section 102 of P.L. 93-638, as Amended; and
- WHEREAS, The Tribal Business Council has determined the Project would be most beneficial to the local economy and can be completed in an expeditious manner under a Section 102 P.L. 93-638 (As Amended) Contract,
- NOW, THEREFORE, BE IT RESOLVED, that the Tribal Business Council of the Three Affiliated Tribes hereby authorizes and directs the execution and submittal of a P.L. 93-638 Application for repair work by the Tribe, at the Mandaree School to consist of the following:

"Replace Doors and Hardware; Mandaree Day School; Fort Berthold Agency. Job includes all plant, labor, equipment, and materials required to replace doors and hardware on approximately 55 doors in Building #215 and install a exit light on Building #236."
