

RESOLUTION
OF THE
GOVERNING BODY
OF THE
THREE AFFILIATED TRIBES
OF THE
FORT BERTHOLD INDIAN RESERVATION

WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and

WHEREAS, The Constitution of the Three Affiliated Tribes generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefits of the Tribes and of the enrolled members thereof; and

WHEREAS, The Natural Resources Committee of the Tribal Business Council approved the exchanges of land between the Three Affiliated Tribes and Diana Lone Fight, under the terms and conditions stated below; and

NOW THEREFORE, BE IT RESOLVED, That the Three Affiliated Tribes Tribal Business Council approves the exchange of lands described below, exclusive of minerals, held in trust by the United States of America for the Three Affiliated Tribes and lands held in trust by the United States of America for the Diana Lone Fight, 301-U4433, hereby authorized the Chairman of the Tribal Business Council, its Secretary, and Superintendent of the Fort Berthold Agency, the Area Director, and the Commissioner of Indian Affairs to prepare all documents and to do all things necessary to exchange lands for which title is to be transferred to the tribe and Diana Lone Fight, under the terms and condition as stated below:

Diana Lone Fight

394A-D NE1/4NW1/4, NE1/4NW1/4NW1/4, S1/2NW1/4NW1/4 11-150-92 containing 70 acres, exchanging an undivided 25/112 interest containing 15.75 acres valued at \$1,651.79

Tribal Land

521A-C N1/2SW1/4 34-152-94 containing 80 acres, exchanging an undivided 23/100 interest, containing 18.40 acres valued at \$1,656.00

The Tribe will waive the difference of \$4.21 to Ms. Lone Fight.
