- WHEREAS, the Tribal Business Council of Fort Berthold Reservation recognizes the need to create a positive long term Reservation Extention Service; and
- WHEREAS, the Tribal Business Council fully understands that the Reservation Extention does provide many necesary programs for youth and agriculture producers on Fort Berthold Reservation.
- NOW, BE IT RESOLVED, that the Tribal Business Council of the Three Affiliated Tribes, formally determines that it will approve funding for support services to the Reservation Extention Service in the amount of \$5000.00.

Secretary Rabbithead made motion to approve, seconded by Vice Chairman Johnson.

A remark was made that this amounts to subsidizing the US Government's trust responsibility and it goes against what we are trying to do in recovering the docket funds.
