- WHEREAS, This Nation, having accepted the Indian Reorganization Act of June 18, 1934 and authority under said Act; and
- WHEREAS, The Constitution and By-laws of the Three Affiliated Tribes authorizes and empowers the Tribal Business Council to engage in activities for the welfare and benefit of the Tribe and tribal members thereof; and
- WHEREAS, Three Affiliated Tribes Tribal Council places the education of its children as one of the highest prioritites on the Fort Berthold Reservation, and
- WHEREAS, The North Dakota Department of Public Instruction and the Office of Vocational Rehabilitation jointly received a grant to develop and implement a comprehensive statewide system of transition planning and services delivery for youth with disabilities from ages fourteen (14) through school exit as required by the "Individual with Disabilities Act", and
- WHEREAS, The four (4) Indian Reservations were identified in the project as the Ninth Planning Region which will require developing and establishing a Regional Governing Board to access funding through the state under the grant to undertake transition activities to meet specific needs on the Indian Reservations through the Regional Rehabilitation Counselor who will be responsible for; coordination and planning activities for the region and further carry out directive of the governing board, serve on local committees, provide training to agencies, parents, and students within the region as well as provide rehabilitation counseling services for students, and coordinate vocational evaluation procedures, and
- WHEREAS, The Regional Governing Board membership needs a representative from the Fort Berthold Reservation who works in an education setting with students high school age, and
- NOW THEREFORE BE IT RESOLVED, That the Three Affiliated Tribes
 Tribal Business Council endorses the development of a
 Comprehensive Statewide System of Transition Planning
 and Service Delivery for youth ages fourteen (14) through

BE IT FURTHER RESOLVED, that Bernadine Young Bird, Tribal Education Administrator, who was involved in the initial planning of the project, or her designee be designated to serve on the Regional Governing Board along with other Native Americans from the other three (3) Indian Reservations to ensure equal and quality representation on the board from the Fort Berthold Reservation with children in need of rehabilitation and counseling services.
