**RESOLUTION  
OF THE  
GOVERNING BODY  
OF THE  
THREE AFFILIATED TRIBES  
OF THE  
FORT BERTHOLD INDIAN RESERVATION**

WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and

WHEREAS, The Constitution of the Three Affiliated Tribes generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefits of the Tribes and of the enrolled members thereof; and

WHEREAS, The Natural Resources Committee of the Tribal Business Council approved the purchase of land described below; and

WHEREAS, It has been determined that it is in the best interest of the Tribe to acquire the land; and

NOW THEREFORE, BE IT RESOLVED, That the Three Affiliated Tribes Tribal Business Council approves the purchase of lands described below, exclusive of minerals, from

Alisa L. Smith, 301-U5190

for cash consideration of \$2,333.78 which is the present fair market value, utilizing funds from the FmHA Land Purchase account, and hereby authorized the Chairman of the Tribal Business Council, its Secretary, and Superintendent of the Fort Berthold Agency, the Area Director, and the Commissioner of Indian Affairs to prepare all documents and to do all things necessary to transfer title of the lands to the United States of America in trust for the Three Affiliated Tribes of the Fort Berthold Indian Reservation, to wit.

- 146 An undivided 1/100 interest within W1/2W1/2 Sec. 23, T. 149 N., R. 94 W., containing 1.60 acres, valued at \$147.68
- 2257-A An undivided 1/5 interest within SW1/4SW1/4, NE1/4SW1/4 Sec. 29, T. 149 N., R. 94 W., containing 16.00 acres, valued at \$1,520.00
- 1583 An undivided 1/7 interest within NW1/4SE1/4 Sec. 29, T. 149 N., R. 94 W., containing 5.71 acres, valued at \$571.43.

- 296A An undivided 1/270 interest within S2SE4SW4, W2SE4SE4, SW4SE4 Sec. 15; N2NW4NE4, N2NW4 Sec. 22, T. 150 N., R. 93 W., containing .67 acres, valued at \$56.67.
- 653A An undivided 1/300 interest within NE4NE4, N2SE4NE4, SE4SE4NE4, N2NW4NE4, SE4NW4NE4, N2NE4NW4 Sec. 11, T. 149 N., R. 92 W., containing .40 acres, valued at \$38.00.
