- WHEREAS, Pursuant to Article XI of the Charter of the Four Bears Community Development Corporation, the members of the Corporation have developed amendments to the bylaws for the Corporation; and
- WHEREAS, It is the considered position of the Tribal Business Council that it would be in the best interest of the members of the Four Bears Community Development Corporation to approve said proposed amendments to the bylaws;
- NOW, THEREFORE, BE IT RESOLVED, That, pursuant to its constitutional power and authority, the Tribal Business Council of the Three Affiliated Tribes hereby approve the amendments to the Bylaws of the Four Bears Community Development Corporation, a true and correct photostatic copy of the amendments to the Bylaws is attached hereto.

AMENDMENTS

To the BYLAWS of the Four Bears Community Development Corporation

Article V MEETINGS OF MEMBERSHIP

REPLACE SECTION 1. - Regular Meetings to read as follows

Section 1. Annual Meetings.

An Annual meeting shall be held by the membership of the corporation for the purpose of reporting to the membership, the business of the Four Bears transaction highlights of the previous year. The annual meeting shall be held the 2nd Tuesday of January, beginning in 1994 and every year there after.

AMENDMENT TO SECTION 4. Quorum - first paragraph to read as follows:

Section 4. Quorum.

Except as provided in Article VI, Section 5, a quorum at any meeting of the membership shall be constituted by a majority of the Board of Directors, or by ten percent (10%) of the membership.

ARTICLE VI BOARD OF DIRECTORS

REPLACE SECTION 3. Election of Directors - first paragraph to read as follows:

Section 3. Election of Directors.

There shall be an Annual Election of the Board of Directors conducted by secret ballot. The election of the Board of Directors shall arranged to provide for staggered terms. Each member of the Board of Directors shall be elected to serve a term of Two (2) years. The Two (2) Directors receiving the highest number of votes cast in the most recent election, shall receive the first, Two (2) year terms. The election shall be held annually on the First Tuesday of November beginning in 1993.

AMENDMENT TO SECTION 8. Bonding to read as follows:

Section 8. Bonding.

Each member of the Board of Directors shall be bonded in the amount deemed appropriate and reasonable, when so required by the membership of the Corporation at a special meeting thereof. The amount of such proposed bonding shall be approved by the Tribal Business Council of the Three Affiliated Tribes.
