RESOLUTION OF THE GOVERNING BODY OF
THE THREE AFFILIATED TRIBES OF THE
FORT BERTHOLD RESERVATION

WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934 and have the authority under said Act; and

WHEREAS, The Constitution and By-Laws of the Three Affiliated Tribes authorizes and empowers the Tribal Business Council to engage in activities for the welfare and benefit of the Tribe and Tribal Members; and

WHEREAS, The Constitution and By-Laws of the Three Affiliated Tribes empowers the Tribal Business Council to revise the membership rolls and to govern future membership rolls; and

WHEREAS, Trudy A. Chase, DOB: 5/27/58, an enrolled member of the Standing Rock Sioux Tribe has applied under conditional relinquishment from Standing Rock to the Three Affiliated Tribes.

WHEREAS, Up to this date, Trudy has never received a payment of any kind from the Standing Rock Sioux Tribe and she wishes to be enrolled at Fort Berthold where she has lived all her live with her family.

THEREFORE BE IT RESOLVED, that Trudy A. Chase be enrolled into the membership of the Three Affiliated Tribes and her name be listed on the official membership roll of the Three Affiliated Tribes.

Trudy states that she wishes to be enrolled at Fort Berthold because she has lived here all her life, her family lives here, and this is her home.
