RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD RESERVATION

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934 and having the authority under said Act; and
- WHEREAS, The constitution and By-Laws of the Three Affiliated Tribes authorizes and empowers the Tribal Business Council to engage in activities for the welfare and benefit of the Tribe and Tribal Members; and
- WHEREAS, According to Article II, Sec. 1: Membership: The membership of the Three Affiliated Tribes shall consist of:
 - A. All persons whose names appear on the membership of the Tribe as of October 2, 1974.
 - B. Any person born after the effective date of the amendment and to any members of the Tribe who was a resident of the reservation at the time of birth of said person.
 - C. All persons of at least 1/4 degree Indian blood of a federally recognized Tribe, provided that at least 1/8 be of Hidatsa, Mandan and Arikara Tribes.
- WHEREAS, The children of Clarice G. (Fox) Salamanca 301-U-2801 DOB: 11/28/53, 4/4 blood degree have an error in their blood degree.
- WHEREAS, Based on the 1936 Base Roll, there were two individuals with the name of Martha Fox who had a blood degree of 7/8 Arikara and 4/4 Arikara. The 4/4 full blood degree Martha Fox is the true grandparent of these children and not the 7/8 blood degree as initially documented.
- WHEREAS, Martha Salamanca 301-U-7636 DOB: 6/27/70 15/32 degree Indian blood and Antonio Salamanca 301-U-7635, DOB: 5/25/71, 15/32 blood degree be changed to 1/2 blood degree.
- NOW THEREFORE BE IT RESOLVED, That the Tribal Business Council duly and officially approves the change in degree of Indian blood for Martha and Antonio Salamanca to 1/2 degree Indian blood.

Clarice G. Fox (Salamanca) U-2801 DOB: 11-28-53, 4/4 blood degree is the mother of the children listed below:

Martha Salamanca U-7636 DOB: 06-27-70 15/32 Antonio Salamanca U-7635 DOB: 05-25-71 15/32 Anna Mae Fox U-7418 DOB: 07-30-75 1/2

It has come to my attention that there has been an error in the blood degree of the Salamanca children. There are two individuals with the name of Martha Fox in the 1936 Base Roll, one is 7/8 and the other is 4/4, both are Arikara. The 4/4 full blood Martha Fox is the true Grandparent of these children, however; the Martha Fox of 7/8 degree of Indian blood was mistaken as Martha and Antonio Salamanca's natural Grandparent. Therefore, I now make a recommendation to correct the blood degree of Marth Salamanca and Antonio Salamnca to show 1/2 instead of 15/32.
