- WHEREAS, Thor Vincent White, 301-U8649 and Roxanne Lynn Jones, 301-U-6649 have requested relinquishment of their memberships from the Three Affiliated Tribes.
- NOW THEREFORE BE IT RESOLVED, that Thor Vincent White and Roxanne Lynn Jones are relinquished from the membership of the Three Affiliated Tribes and their names are to be removed from the official membership roll of the Three Affiliated Tribes.
