

RESOLUTION OF THE GOVERNING BODY OF
THE THREE AFFILIATED TRIBES OF THE
FORT BERTHOLD RESERVATION

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934 and have the authority under said Act; and
- WHEREAS, The Constitution and By-Laws of the Three Affiliated Tribes authorizes and empowers the Tribal Business Council to engage in activities for the welfare and benefit of the Tribe and Tribal Members; and
- WHEREAS, The Constitution and By-Laws of the Three Affiliated Tribes empowers the Tribal Business Council to revise the membership rolls and to govern future membership rolls; and,
- WHEREAS, Thor Vincent White, 301-U8649 and Roxanne Lynn Jones, 301-U-6649 have requested relinquishment of their memberships from the Three Affiliated Tribes.

NOW THEREFORE BE IT RESOLVED, that Thor Vincent White and Roxanne Lynn Jones are relinquished from the membership of the Three Affiliated Tribes and their names are to be removed from the official membership roll of the Three Affiliated Tribes.

C E R T I F I C A T I O N

I, the undersigned, as Secretary of the Tribal Business Council of the Three Affiliated Tribes of the Fort Berthold Reservation hereby certify that the Tribal Business Council is composed of seven (7) members of whom five (5) constitute a quorum, 6 were present at a special meeting thereof duly called, noticed, convened and held on the 23rd day of November, 1994; that the foregoing resolution was adopted at such meeting by the affirmative vote of 4 members, 1 members abstained, 1 members opposed and that the said resolution has not been rescinded or amended in any way.

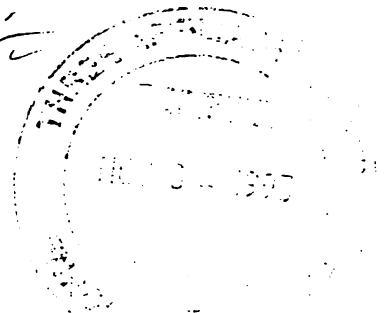

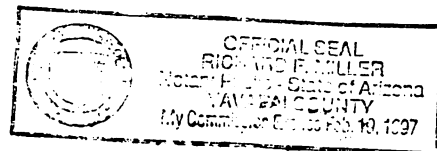
