RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD RESERVATION

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934 and having the authority under said Act; and
- WHEREAS, The constitution and By-Laws of the Three Affiliated Tribes authorizes and empowers the Tribal Business Council to engage in activities for the welfare and benefit of the Tribe and Tribal Members; and
- WHEREAS, According to Article II, Sec. 1: Membership: The membership of the Three Affiliated Tribes shall consist of:
 - A. All persons whose names appear on the membership of the Tribe as of October 2, 1974.
 - B. Any person born after the effective date of the amendment and to any members of the Tribe who was a resident of the reservation at the time of birth of said person.
 - C. All persons of at least 1/4 degree Indian blood of a federally recognized Tribe, provided that at least 1/8 be of Hidatsa, Mandan and Arikara Tribes.
- WHEREAS, The parents of Morgan B. Stiffarm 301-U-6164 have requested an increase in their son's blood degree. The parents are Phillip and Truby Stiffarm (an enrolled member, 301-U-1841, DOB: 3/30/48).
- WHEREAS, Morgan is listed as 1/2 Hidatsa and has proof of being 15/32 Montana Gros-Ventre + 1/32 Arapaho which equals 4/4 full blood. At the time of his enrollment, his father's blood quantum was not included.
- NOW THEREFORE BE IT RESOLVED, That the Tribal Business Council duly and officially approves the change in degree of Indian blood for Morgan B. Stiffarm to 4/4 degree Indian blood.

Phillip and Truby Stiffarm, the parents of Morgan B. Stiffarm U-6164, request a increase in their sons blood degree. Morgan is listed as 1/2 Hidatsa, he has proof of being 15/32 Montana Gros-Ventres + 1/32 Arapaho = 32/32 or 4/4 full blood. At the time of his enrollment his father's blood quantum was not included.
