RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD RESERVATION

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and
- WHEREAS, The Constitution and Bylaws of the Three Affiliated Tribes generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS, Article II "Salaries" of the Three Affiliated Tribes Constitution empowers the Tribal Business Council of the Three Affiliated Tribes to prescribe salaries for tribal employees; and
- WHEREAS, Article VI Section 5(c) of the Three Affiliated Tribes Constitution empowers the Tribal Business Council to administer any funds or property within the exclusive control of the Tribes to make expenditures from available Tribal funds for public purposes of the Tribes, including salaries; and
- WHEREAS, Article VI Section 5(j) of the Three Affiliated Tribes Constitution empowers the Tribal Business Council to protect and preserve the quality of life of the Three Affiliated Tribes of the Fort Berthold Reservation; and
- WHEREAS, The new Administration of the Tribal Business Council of the Three Affiliated Tribes has been encumbered with the shortfall of revenue due to over-expenditures of the previous Administration of the Three Affiliated Tribes; and
- WHEREAS, The Tribal Business Council of the Three Affiliated Tribes has concluded that there is no other alternative but to reduce salaries and personnel to ensure the financial stability of the Three Affiliated Tribes of the Fort Berthold Reservation; and
- NOW, THEREFORE, BE IT RESOLVED, That the Tribal Business Council of the Three Affiliated Tribes hereby approves the reduction of salaries and personnel as provided in the Master Listattachment hereto.
