- WHEREAS, The Three Affiliated Tribes Tribal Business Council has reviewed the status of the FY-1994 Docket Funds income earnings per the 09-30-94 Detail of Trust Funds Summary report; and
- NOW, THEREFORE, BE IT RESOLVED, that the Three Affiliated
  Tribes Tribal Business Council hereby approves the
  withdrawal for earnings for the Docket Funds for FY-95
  Tribal operations; and
- BE IT FURTHER RESOLVED, that the Tribal Chairman and Tribal Treasurer can disburse funds as authorized by the Plan. The attachment of the allocation for these monies describes this plan.
