

RESOLUTION OF THE GOVERNING BODY OF THE
THREE AFFILIATED TRIBES OF THE
FORT BERTHOLD RESERVATION

WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and

WHEREAS, The Constitution of the Three Affiliated Tribes generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the best interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and

WHEREAS, Article VI, Section 5(c) grants the authority to the Tribal Business Council to make expenditures from available Tribal funds for public purposes of the Tribes, including salaries or other remuneration of Tribal employees; and

WHEREAS, As the result of thorough review and analysis, the Tribal Treasurer has developed the position that adjustments to Tribal expenditures relative to employees salaries are necessary to ensure the financial stability of the Three Affiliated Tribes; and

WHEREAS, There is a need to reduce salary expenditures within our Finance System identified within line item 1001 (see attached list);

NOW, THEREFORE, BE IT RESOLVED, that the Tribal Business Council does hereby approve of the reductions of salaries as provided in the attached list, such reductions to be completed and adjusted by the Personnel and Finance offices by May 21, 1995.
