RESOLUTION OF THE GOVERNING BODY OF
THE THREE AFFILIATED TRIBES OF THE
FORT BERTHOLD RESERVATION

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and
- WHEREAS, The Constitution of the Three Affiliated Tribes generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS, Pursuant to Article 1, Section 1, of the Constitution and Bylaws of the Three Affiliated Tribes, "He/She (the Chairman) shall appoint, subject to the approval of the Council, such standing committees and special Committees and other officers as the business of the Tribe may require."; and
- WHEREAS, The Tribal Business Council previously adopted the Tribal Council Committee Guidelines (#89-185-TL); and
- WHEREAS, The 1994 General Election has caused changes in the membership of the Tribal Business Council, and new council members must be seated to the various Committees and boards; and
- WHEREAS, The Tribal Business Council of the Three Affiliated Tribes hereby approves of the appointment of the following members to the following respective committees and boards of the Tribal Business Council:
