- WHEREAS, The U.S. Department of Health & Human Services (DHHS), Administration for Children & Families (ACF), Head Start Bureau American Indian Program, Region 11, under Public Law 97-35 grants fiscal service to the Three Affiliated Tribes Head Start via Grant #90-CI-0203;
- WHEREAS, Three Affiliated Tribes Head Start presents Continuation Application for Budget Period: January 1, 1996 December 31, 1996, based on refunding level referenced in Head Start Bureau, Grant #90-CI-0203 as follows: Total Federal Allocation: \$870,623, {PA-20: \$9,500, PA22+22DS: \$861,123}, with Non-Federal Share @ 10% or \$96,736; Total Federal & Grantee Outlay @ \$967,359;
