- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934 and the authority under said Act; and
- WHEREAS, The Constitution of the Three Affiliated Tribes generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of the Tribes and of the enrolled members thereof; and
- WHEREAS, The Three Affiliated Tribes Education Philosophy and mission states that "the development of individual and community responsibility and accountability to ensure that all tribal members-the unborn to adult-will obtain the intellectual, cultural, social, spiritual and physical development necessary to be a self-sufficient, productive and contributing member of the nation.", and
- WHEREAS, "The Federal Law P.L. 99-457/IDEA Individuals with Disabilities Education Act the Education of the Handicapped Amendments of 1986 (amends P.L. 94-142) include a mandate for the provision of educational and related services for the disabled Birth to 21 years of age. In order to ensure that a free appropriate public education is provided for every exceptional child a Child Find search (25 CFR 45. 11-12) should be conducted on a regular basis. The search includes all children ages birth to twenty-one years.
- WHEREAS, The Three Affiliated Tribes recognizes the importance of the Child Find effort and early intervention for children and families on Fort Berthold; and
- WHEREAS, The State of North Dakota designates the second week of September as Child Find Week and the Three Affiliated Tribes desires to supplement that effort; and
- NOW, THEREFORE BE IT RESOLVED, that the month of September be designated as the <u>Three Affiliated Tribes Child Find Month</u> each year forthwith; and
- FURTHER BE IT RESOLVED, that all agencies/programs working for the children and families of Fort Berthold, plan and coordinate efforts with the Education Department and schools for Child Find Activities.
