

RESOLUTION OF THE GOVERNING BODY OF
THE THREE AFFILIATED TRIBES OF THE
FORT BERTHOLD RESERVATION

WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the statutory authority under said Act; and

WHEREAS, The Constitution of the Three Affiliated Tribes generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the enrolled members thereof; and

WHEREAS, Chapter 27 of the Code of Laws of the Three Affiliated Tribes, Section 4, provides that the Three Affiliated Tribes Gaming Commission is authorized to prepare and submit a budget sufficient to carry out the duties of the Commission under the Gaming Ordinance; and

WHEREAS, The Tribal Gaming Commission has submitted to the Tribal Business Council requests for financial support in through out this fiscal year; and

WHEREAS, The Tribal Business Council deems such financial request to be in the best interest of the Fort Berthold Reservation and will contribute positively to the necessary regulation of gaming on the Fort Berthold Reservation;

NOW, THEREFORE, BE IT RESOLVED, That the Tribal Business Council hereby approves a tribal financial contribution to the Three Affiliated Tribes Gaming Commission in the amount of \$47,877.96
