RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD RESERVATION

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and
- WHEREAS, The Constitution of the Three Affiliated Tribes generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS, Article VI, Section 5 (c), of the Three Affiliated Tribes Constitution, specifically grants the Tribal Business Council power to administer any funds or property within the exclusive control of the Tribes to make expenditures from available Tribal funds for public purposes of the Tribes, including salaries or other remuneration of Tribal officials or employees; and
- WHEREAS, All expenditures from said fund shall be by resolution duly passed by the Tribal Business Council to such effect; and
- WHEREAS, The Tribal Business Council is desirous of approving Fiscal Year 1995 Tribal Business Council Administration/Revenue Budget Account.
- NOW, THEREFORE, BE IT RESOLVED. That the Tribal Business Council has reviewed and hereby approves the attached budget for the Tribal Business Council Tribal Administration/Revenues Budget Account for Fiscal Year 1995 in the amount of \$3,560,767:
