## RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD RESERVATION

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said. Act; and
- WHEREAS, The Constitution of the Three Affiliated Tribes generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS, The Three Affiliated Tribes Tribal Business Council recognizes the need for an expectation system to provide access for the Tribal country and
- WHEREAS, The Trans Business Council has determined that the Bureau of Indian Affairs should proceed with the construction of several highway and street projects on the Fort Berthold Reservation; and
- WHEREAS, The Three Affiliated Tribes is being required by Bureau of Indian Affairs via The Federal Highway Administration to develop and maintain a Transportation Improvement List; and
- WHERE AS, The Three Affiliated Tribes has sought and has obtained public input into the development and planning of it's transportation system as required by the Bureau of Indian Affairs; and
- WHERE AS, The Three Affiliated Tribes' Business Coucil has met and approved a new Transportation Improvement list as follows;
  - 1. Parshall Streets
  - 2. Mandaree Streets & Pedestrian Crossing
  - 3. White Shield Streets
  - 4. Cemetery Road Project
  - 5. Bakersfield Streets Project
  - 6. Route 20, Twin Buttes
  - 7. Mandaree Streets
  - Streets Addition at Drags Wolf Village
