Mayer has submitted a proposed loan agreement, titled "Memorandum of Agreement" (which document is attached hereto), wherein Ms. Mayer has set forth all of the considerations and requirements relating to the loan, including her express desire and intent to practice medicine on the Fort Berthold Reservation upon completion of her medical residency; and
- WHEREAS, Based on its comprehensive review of the attached Memorandum of Agreement and in the interest of encouraging Tribal members with M.D. degrees to practice on the Reservation for the benefit of their people, it is the considered judgment of Tribal Business Council that the loan request submitted by Monica M. Mayer should be granted;
- NOW, THEREFORE, BE IT RESOLVED, That the Tribal Business Council of the Three Affiliated Tribes hereby grants to Monica M. Mayer a loan in the amount of Twenty-Five Thousand Dollars (\$25,000.00) and authorizes and directs the Chairman and the Treasurer of the Council to execute on behalf of the Three Affiliated Tribes duplicate copies of the attached Memorandum of Agreement.

MEMORANDUM OF AGREEMENT

THIS AGREEMENT, made and entered into this ______ day of January 1996, by the Three Affiliated Tribes Tribal Business Council, acting for and on behalf of the Three Affiliated Tribes of North Dakota, and Monica M. Mayer, M.D., P.O. Box 634, New Town. North Dakota.

WITNESSETH:

That the Three Affiliated Tribes Tribal Business Council, hereinafter referred to as the TRIBE, hereby contracts with Monica M. Mayer, M.D., and the parties agree to the matters hereinafter mentioned:

- 1. That the TRIBE shall loan to Monica M. Mayer, M.D. the sum of \$25,000 (twenty-five thousand dollars), interest free, to be utilized to defray costs and expenses to maintain a domicile in Minot, North Dakota throughout the term of her medical residency with an expected completion date in December 1998.
- 2. That Monica M. Mayer, M.D. shall designate the Fort Berthold Indian Reservation as the site for her completion of the required four-year service payback under the Indian Health Service's P.L. 94-437 contract service.
- 3. That the TRIBE shall grant loan forgiveness in the amount of \$5,000 (five thousand dollars) per year for each year that Monica M. Mayer, M.D. maintains employment as a Medical Doctor on the Fort Berthold Indian Reservation.
- 4. That Monica M. Mayer, M.D. shall be permitted to accelerate full payment of any outstanding loan balance under this agreement at any time prior to the expiration of the agreement.
- 5. That this agreement shall be terminated without further obligation under the agreement on the part of Monica M. Mayer, M.D. or her estate, in the event that she should be unable to fulfill the terms of this agreement due to circumstances beyond her control. Such circumstances shall include her death or physical or mental incapacity.

- 6. That this agreement shall be in force throughout the period from the date set forth hereinabove to the date on which Monica M. Mayer M.D. has fully satisfied her loan repayment obligation in accordance with Clause 9 hereinbelow, as read in its entirety.
- 7. That commencement of the obligation to repay the loan proceeds shall be deferred until such time as Monica M. Mayer, M. D. has completed her medical residency.
- 8. That the loan repayment obligation shall commence upon entry into an employment agreement between Monica M. Mayer, M.D. and the Indian Health Service. All terms of such employment agreement, including supervision, shall remain within the exclusive control of Monica M. Mayer, M.D. and the Indian Health Service.
- 9. That, subject to Clauses 3, 4, and 5 hereinabove, Monica M. Mayer, M.D. shall repay the loan proceeds to the Tribe as follows: equal quarterly payments shall be made in the amount of \$1,250 (one thousand, two hundred, fifty dollars), the first quarterly payment to be made on the 1st day of the fourth full month after the date on which Monica M. Mayer, M.D. actually commences her employment with the Indian Health Service.
