# RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

WHEREAS, this Nation having accepted the Indian Reorganization Act of June 18, 1934 and the authority under said Act; and

WHEREAS, the Constitution of the Three Affiliated Tribes generally authorizes and empowers the Tribal Business Council to engage in activities on behalf and in the best interests of the welfare and benefit of the Tribes and of the enrolled members thereof including the protection and preservation of property, wildlife and natural resources; and

WHEREAS, the Indian agricultural operators and ranchers of this Nation have, in the past, encountered difficulty in obtaining full access to USDA programs administered by the local county Agricultural Stabilization and Conservation Service (ASCS), Natural Resources Conservation Service (NRCS) and the Farm Service Agency (FSA);

NOW, THEREFORE, BE IT RESOLVED that, in order to bring USDA programs, including the formation of a Tribal USDA service center, to the Reservation, the Tribal Business Council authorizes the establishment of a Memorandum of Agreement between the Three Affiliated Tribes and the USDA; and

BE IT FURTHER RESOLVED that the Tribes intend to establish a Fort Berthold Conservation District based upon the exterior boundaries of the Fort Berthold Reservation, and, to this end, the Tribal Business Council authorizes the Tribal Chairman to submit a letter to the USDA requesting the designation of the Fort Berthold Reservation boundaries as a Conservation District under the 1994 Reorganization Act.
