- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and
- WHEREAS, The Constitution of the Three Affiliated Tribes generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS, Pursuant to Article 1, Section 1, of the Constitution and Bylaws of the Three Affilaited Tribes, "The Chairman shall appoint, subject to the approval of the Council, such standing committees and special committees and other officers as the business of the Tribe may require"; and
- WHEREAS, Public Law 93-638 requires a Tribal Organization Chart be adopted and utilized for the administration of any and all 93-638 Contracts; and
- WHEREAS, The standing Committees and Special Committees are not static in nature and need to be revised/amended from time to time to stay current; and
- WHEREAS, The attached Organizational Charts have been revised/amended and require approval and adoption by the Tribal Business Council.
- NOW, THEREFORE, BE IT RESOLVED, The Three Affiliated Tribes Tribal Business Council hereby approves and adopts the attached Organizational Charts:

1. Three Affiliated Tribes Tribal Business Council Committees Organizational Chart;

2. Three Affiliated Tribes Tribally Chartered Corporations and Enterprises;

3. Three Affiliated Tribes Organizational Chart Staffing and Line of Authority.

BE IT FURTHER RESOLVED, That the attached Organizational Charts are the most current and supersede previous actions taken by the Tribal Business Council regarding Organizational Structure of the Three Affiliated Tribes.


