## RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD RESERVATION

- WHEREAS, This Nation, having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and
- WHEREAS, The Constitution of the Three Affiliated Tribes generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the best interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS, The Three Affiliated Tribes wishes to become a Member Indian/Native Government in Good Standing of the National Congress of American Indians; and
- WHEREAS, The Three Affiliated Tribes meets all requirements for Tribal Membership pursuant to Article II, Section (b) of the Constitution and By-Laws of the National Congress of American Indians; and
- NOW THEREFORE BE IT RESOLVED That the Tribal Business Council, the official governing body of the above-named Tribe/Nation, hereby authorizes Russell D. Mason, Sr., Chairman of the Tribal Business Council, who is the principle official of the Three Affiliated Tribes, to take the necessary action to place the Tribe/Nation in membership with the National Congress of American Indians (NCAI);
- BE IT FURTHER RESOLVED That Tribal funds in the amount of One Thousand Dollars dollars (\$1,000.00) based on the tribal membership dues schedule to the NCAI By-Laws, Article III, Section (b), are authorized to be paid such Tribal Membership in NCAI;
- BE IT FURTHER RESOLVED That, based on the tribal citizenry of ten thousand one hundred and sixty three (10,163), the Tribe shall have one hundred and eighty (180) votes in accordance with Article IV, Section 3 of the NCAI Constitution;
- **FURTHER, BE IT RESOLVED** That, pursuant to Article V, Section 2 of the NCAI Constitution, the Tribe designates the following-named persons:
