WHEREAS, The Constitution of the Three Affiliated Tribes generally

authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes of enrolled members

therefore, and

WHEREAS, Sahnish Farms Cooperative is a newly formed non-profit

American Indian business organization, and

WHEREAS, Sahnish Farms Cooperative purpose is to provide the

educational, technical assistance and conduct research to meet the needs of low-income American Indians who desire to get into farming and make a living as a landowner, and in obtaining agricultural benefits and improving their economic position, and

WHEREAS, Sahnish Farms Cooperative has completed a market/feasibility

study for cultivation of medicinal plants, namely echinacea

angustifolia, and

WHEREAS, Members lack the necessary capital to actually put the work plan

into practice, either jointly or individually, and

WHEREAS, Sahnish Farms Cooperative is requesting financial assistance for

start-up capital in the amount of \$29,500 from the Tribal Business

Council's economic development funds; now


THEREFORE, BE IT RESOLVED, the Three Affiliated Tribes of the Fort Berthold Reservation

BE IT FURTHERED RESOLVED, the Three Affiliated Tribes will commit \$29,500, from their

a \$20,000 loan and a \$9,500 grant, and
