

**RESOLUTION OF THE GOVERNING BODY  
OF THE THREE AFFILIATED TRIBES OF THE  
FORT BERTHOLD RESERVATION**

WHEREAS, This nation having accepted the Indian Reorganization Act of June 18, 1934, and the statutory authority under said Act; and

WHEREAS, The Constitution of the Three Affiliated Tribes generally authorized and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and the enrolled members thereof; and

WHEREAS, The Gaming Compact between the Three Affiliated Tribes and the State of North Dakota requires the Tribe to establish an Escrow Account in order to reimburse the State for fees and other costs incurred by the State in their endeavors to insure compliance with the Tribal/State Compact; and

THEREFORE BE IT RESOLVED, The Three Affiliated Tribes, in efforts to continue to comply with the Tribal/State Gaming Compact, hereby amends resolution No. 96-230: and

THEREFORE BE IT RESOLVED, The Tribal Business Council hereby appoints the Tribal Treasurer, Thomas Bird Bear, and the Tribal Liaison, Carol Good Bear, to be the signatory agents representing the Three Affiliated Tribes; and

THEREFORE BE IT RESOLVED, The Tribal Business Council hereby includes the Tribal Chairman, Russell Mason, on the account signature card, in the event that the Tribal Treasurer cannot be reached for concurrence; and

THEREFORE BE IT RESOLVED, The Tribal Business Council officially recognizes and approves of the Financial Administrator, Kathy Roll, representing the Office of the Attorney General, North Dakota State Gaming Division, to be included on the signature card; and

THEREFORE BE IT RESOLVED, That the Lakeside State Bank may release payments to the State of North Dakota upon the following two condition:

1. The Bank receives official notice, in writing, from the Three Affiliated Tribes signatory agent, Carol Good Bear, that the billing statements presented to the Tribe are approved for payment.
2. The State of North Dakota, Office of the Attorney General, Gaming Division Financial Administrator, Kathy Roll, requests the Lakeside State Bank to release payment.

BE IT FURTHER RESOLVED, That the Tribal Treasurer, Thomas Bird Bear, and Tribal Liaison, Carol Good Bear, take all necessary steps to implement this resolution.
