

RESOLUTION OF THE GOVERNING BODY
OF THE
THREE AFFILIATED TRIBES
OF THE
FORT BERTHOLD INDIAN RESERVATION

WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and

WHEREAS, The Constitution of the Three Affiliated Tribes authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interests of the welfare and benefits of the Tribe and of the enrolled members thereof; and

WHEREAS, The Tribal Business Council is submitting an Application for Mobile Radio Service Authorization to the Federal Communications Commission (FCC) to obtain a federal license for a high-band frequency for use by the Bureau of Indian Affairs and Three Affiliated Tribes Police Departments. The license will be maintained for as long as it is required by the Bureau of Indian Affairs and the Tribe.

WHEREAS, It has been determined that it is in the best interests of the Tribe to obtain a federal license to (1) protect the confidentiality of the general public who report thefts, vandalism, and other acts of crime to the police departments, (2) prevent encryption of the frequency by the general public, (3) protect names of victims involved in misdemeanor or federal crimes, (4) protect names of minors involved in juvenile incidents, and (5) allow police departments to coordinate activities to deter criminal activities and investigate criminal acts.

WHEREAS, This action by the Tribal Business Council will greatly assist and enhance the law enforcement program so that all members, citizens, and the general public are protected within the exterior boundaries of the Fort Berthold Reservation.
