- WHEREAS, This nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act;
- WHEREAS, The Three Affiliated Tribes Constitution authorizes and empowers the Mandan, Hidatsa, & Arikara Tribal Business Council to engage in activity on behalf of and in the interest of Enrolled Members, thereof; and
- WHEREAS, The U.S. Department of Health & Human Services (DHHS), the Administration for Children & Families (ACF), and the Head Start Bureau/American Indian Programs Branch (AIPB), under Public Law 97-35 provides financial assistance to the Three Affiliated Tribes Head Start;
- WHEREAS, Three Affiliated Tribes Head Start of Fort Berthold confirms DHHS's offer to increase Grant #90-CI-0203's base operation level of \$861,123 with \$11,222 PA20 T/TA; PA22 -Transition funds @ \$14,645; COLA @ \$25,397; and Quality Improvement Funds @ \$18,855; based on the refunding level @ \$60,619 referenced in Head Start Bureau, American Indian Programs;
- WHEREAS, Three Affiliated Tribes Head Start Program Budget FY97 Increased Permanent Funding Level is \$931,242; and
- THEREFORE BE IT RESOLVED, The Tribal Business Council hereby assures compliance with DDHS, ACF, AIPB, and Head Start regulations as part of this Continuation Application request.
- FURTHER BE IT RESOLVED, The Tribal Business Council Chairman is authorized to sign and certify all required forms.
