RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and
- WHEREAS, The Constitution of the Three Affiliated Tribes generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefits of the Tribes and of the enrolled members thereof; and
- WHEREAS; Article VI Section 5 (j) empowers the Tribes to protect and preserve the natural resources of the Fort Berthold Indian Reservation: and
- WHEREAS; The economic distress of the livestock operators of the Three Affiliated Tribes has already been increase by this harsh winter. Then, on April 4, 5, and 6, 1997, the Fort Berthold Indian Reservation suffered one of the worst blizzards recorded.
- WHEREAS; The blizzard occurred during the calving season causing a significant loss of the calf crop as well as the loss of cows and bulls.
- WHEREAS; Livestock operators will be forced to turn their livestock onto the range prematurely due to hay and feed shortages.
- WHEREAS; Additional grain would help condition the weakened cows for breeding, otherwise additional losses will result due to open cows.
- WHEREAS; Additional grain to supplement livestock on the range would help reduce the impact of early grazing on the rangeland.

WHEREAS; It is the policy of the Government to conserve and improve natural and renewable resources such as soil, forage, fish and wildlife in a manner so they contribute to the continued livelihood of people and the subsistence of many Indian people depends upon the livestock use of range forage.

NOW, THEREFORE, BE IT RESOLVED, That in order to help conserve our limited natural resources and reduce the financial hardship of the livestock operators, the Tribal Business Council hereby requests an extension of the current Indian Acute Distress Donation Program until June 30.

BE IT FURTHER RESOLVED, That the daily ration of livestock feed grain under the Indian Acute Distress Donation Program be doubled.
