RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD RESERVATION

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and
- WHEREAS, The Constitution of the Three Affiliated Tribes (the "Tribe") generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS, The Tribe has enacted a Tribal Employment Rights Ordinance (TERO), pursuant to Resolutions No. 83-122-S and No. 93-40-JJR, which requires that Indian people, and particularly members of the Three Affiliated Tribes, be preferred in employment opportunities and contracting projects that occur within the Fort Berthold Indian Reservation; and
- WHEREAS, The Tribal Employment Rights Ordinance also imposes a TERO tax on contracting activities which occur within the Fort Berthold Indian Reservation, without exception, which is used, in part, for funding of the TERO office; and
- WHEREAS, The tax has an adverse impact on contracting projects which involve school construction and Tribal buildings, including buildings constructed for Tribal community use, as no allowance is made by the funding sources for such projects for TERO taxes, and imposing such a tax reduces what can be constructed with the funds available; and
- WHEREAS, The Tribe does not want to impose unnecessary burdens on education of its youth or on the completion of Tribal buildings, including buildings constructed for Tribal community use; and
- WHEREAS, The Tribe can, if needed, provide funding to the TERO office to support its activities from sources other than TERO taxes on school construction and Tribal buildings; now
- **THEREFORE, BE IT RESOLVED**, That the Tribal Business Council of the Three Affiliated Tribes hereby amends the TERO ordinance to add a subsection E. to Chapter 11, Section II -- Prime Contractors/Operators to read as follows:
 - "E. This Section shall not apply to construction contracts on the Fort Berthold Indian Reservation involving any public school."

BE IT FURTHER RESOLVED, That the TERO fee shall not be imposed against either of the respective contracts under which the Four Bears Community Center and the Mandaree Community Center are currently being constructed.
