RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and
- WHEREAS, The Constitution of the Three Affiliated Tribes generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefits of the Tribes and of the enrolled members thereof; and
- WHEREAS, The United States Forest Service is in the process of revising it's Management Plans for the Little Missouri Grasslands; and
- WHEREAS, This revision will include Rangeland and Forest Health, Community and Lifestyle Relationships, Livestock Grazing, Oil & Gas Leasing, Plant and Animal Control, Recreational and Travel Management and Special Area Designations; and
- WHEREAS, All of these topics have potentially great impacts on the Fort Berthold Reservation, such as: Past and current uses of land, Social and demographic changes and trends and Diversity of jobs and income. Quality of life factors and main topics such as livestock grazing, oil and gas leasing and Special Area designations.
- WHEREAS, The National Grazing lands directly adjacent to the Western border of the Fort Berthold Indian Reservation, specifically known as The Little Missouri National Grasslands were once a part of Fort Berthold until the Executive Orders of 1870 and 1880, specifically described as lands within Townships 147, 148, 149, 150, 151 and 152 North, Ranges 95 and 96 West. These lands were once used for Tribal hunting and Ceremonial purposes and now the Three Affiliated Tribes have no access to these lands which are permitted at low cost to non-Indians.
- NOW THEREFORE, BE IT RESOLVED, That the lands directly adjacent to the Fort Berthold Reservation be leased to the Three Affiliated Tribes for grazing, a Buffalo compound and cultural and religious purposes. The Government to Government realtionship shall be utilized to expidite this request prior to the 1998 expiration date of current lease.

ALSO, BE IT FURTHER RESOLVED; That the Blue Buttes Ceremonial areas be designated as a Special Interest Area and the correct historical names be used in this designation. ie: Table Butte aka Thunder Butte aka Eagle Nest Butte and Chimney Butte have alway's been sacred to the Three Affiliated Tribes' Low Cap Clan and Water Buster Clan. Traditional Ceremonies have been performed on these Buttes in the past and at the present time.
