- WHEREAS, ELAINE ALLEN 301U-9225 has requested relinquishment of her membership from the Three Affiliated Tribes.
- WHEREAS, Elaine Allen, is eligible for enrollment with the Yakama Nation of Washington, and has applied for membership.
- NOW THEREFORE BE IT RESOLVED, that Elaine Allen. 301-U9225 is herby relinquished from the official membership roll of the Three Affiliated Tribes.
- BE IT FURTHER RESOLVED, That the Yakama Nation is to be advised of this action by a copy of this approved resolution.


