- WHEREAS, Delphine Lone Bear, is eligible for enrollment with the Assinniboine Sioux Tribe of Fort Peck, Poplar, Montana and has applied for membership.
- NOW THEREFORE BE IT RESOLVED, that Delphine Lone Bear 301-U4253 is hereby relinquished from the official membership roll of the Three Affiliated Tribes.
- **BE IT FURTHER RESOLVED,** That the Assiniboine Sioux Tribe is to be advised of this action by a copy of this approved Resolution.
