- WHEREAS, Catalina Herman 301-U2876 has requested relinquishment of his/her membership from the Three Affiliated Tribes.
- WHEREAS, Catalina Herman is eligible for enrollment with the Spirt Lake Nation of Fort Totten, North Dakota and has applied for membership.
- NOW THEREFORE BE IT RESOLVED, that Catalina Herman. 301-U2876 is hereby relinquished from the official membership roll of the Three Affiliated Tribes.
- **BE IT FURTHER RESOLVED,** That the Spirit Lake Nation is to be advised of this action by a copy of this approved Resolution.
