

RESOLUTION OF THE GOVERNING BODY OF  
THE THREE AFFILIATED TRIBES OF THE  
FORT BERTHOLD RESERVATION

WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and

WHEREAS, The Constitution of the Three Affiliated Tribes generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the enrolled members; and

WHEREAS, The Constitution and By-Laws of the Three Affiliated Tribes empowers the Tribal Business Council to revise the membership rolls and to govern future membership rolls; and

WHEREAS, SAMANTHA JEN BURR 301U-9021 has requested relinquishment of his/her membership from the Three Affiliated Tribes.

WHEREAS, Samantha Jen Burr, is eligible for enrollment with the Mille Lacs Band of Chippewa Indians, Minnesota and has applied for membership.

NOW THEREFORE BE IT RESOLVED, that Samantha Burr. 301-U9021 is hereby relinquished from the official membership roll of the Three Affiliated Tribes.

BE IT FURTHER RESOLVED, That the Mille Lacs Band of Chippewa is to be advised of this action by a copy of this approved Resolution.

C E R T I F I C A T I O N

I, the undersigned, as Secretary of the Tribal Business Council of the Three Affiliated Tribes of the Fort Berthold Reservation, hereby certify that the Tribal Business Council is composed of 7 members of whom 5 constitute a quorum, 7 were present at a Special meeting thereof duly called, noticed, convened, and held on the 21<sup>st</sup> day of July, 1995; that the foregoing Resolution was duly adopted at such meeting by the affirmative vote of 5 members, 2 members opposed, 0 members abstained, and 0 members not voting and that said Resolution has not been rescinded or amended in any way.

he/she is accepted as a member of the Mille Lacs Band of Chippewa Indians. We do expressly  
waive any and all benefits now existing or which may accrue members of the Tribe.

We fully understand that all rights which he/she may have insofar as said rights are based upon enrollment be  
terminated when his/her name is stricken from the rolls.

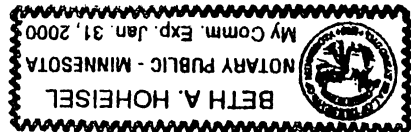
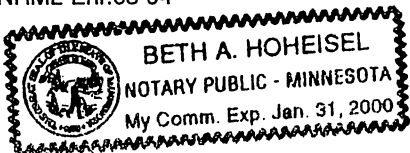
