- WHEREAS, The Constitution and By-Laws of the Three Affiliated Tribes empowers the Tribal Business Council to revise the membership rolls and to govern future membership rolls; and
- WHEREAS, SAMANTHA JEN BURR 301U-9021 has requested relinquishment of his/her membership from the Three Affiliated Tribes.
- WHEREAS, Samantha Jen Burr, is eligible for enrollment with the Mille Lacs Band of Chippewa Indains, Minnesota and has applied for membership.
- NOW THEREFORE BE IT RESOLVED, that Samantha Burr. 301-U9021 is hereby relinquished from the official membership roll of the Three Affiliated Tribes.
- BE IT FURTHER RESOLVED, That the Mlle Lacs Band of Chippewa is to be advised of this action by a copy of this approved Resolution.


