

**RESOLUTION OF THE GOVERNING BODY OF  
THE THREE AFFILIATED TRIBES OF THE  
FORT BERTHOLD RESERVATION**

**WHEREAS,** This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and

**WHEREAS,** The Constitution of the Three Affiliated Tribes generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the enrolled members; and

**WHEREAS,** The Constitution and By-Laws of the Three Affiliated Tribes empowers the Tribal Business Council to revise the membership rolls and to govern future membership rolls; and

**WHEREAS,** MURPHY T. BOLMAN 301-U3888 has requested relinquishment of his/her membership from the Three Affiliated Tribe as membership has been requested and approved with the Lower Brule Sioux Tribe, South Dakota.

**WHEREAS,** A Letter has been received of 07/17/97 stating his name is eligible for membership with the Lower Brule Sioux Tribe and will receive benefits as a member of that tribe.

**NOW THEREFORE BE IT RESOLVED,** that Murphy T. Bolman 301-U3888 is hereby relinquished from the membership roll of the Three Affiliated Tribes.

**BE IT FURTHER RESOLVED,** That the Lower Brule Sioux Tribe is to be advised of this action by a copy of this approved Resolution.

**C E R T I F I C A T I O N**

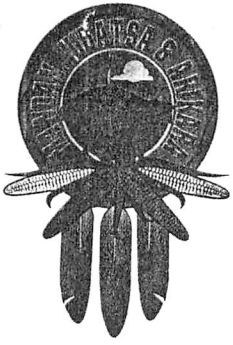

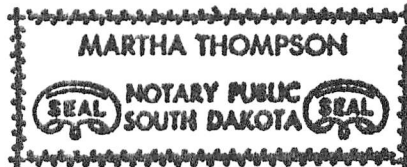
