- WHEREAS, ETHAN N. LOHNES 301-U9849 has requested relinquishment of his/her membership from the Three Affiliated Tribes.
- WHEREAS, Ethan N. Lohnes, is eligible for enrollment with the Spirt Lake Nation of Fort Totten, North Dakota and has applied for membership.
- NOW THEREFORE BE IT RESOLVED, that Ethan Lohnes 301-U9849 is hereby relinquished from the official membership roll of the Three Affiliated Tribes.
- **BE IT FURTHER RESOLVED,** That the Spirit Lake Nation is to be advised of this action by a copy of this approved Resolution.
