- WHEREAS, The Constitution and Bylaws of the Three Affiliated Tribes authorizes and empowers the Tribal Business Council to engage in activities for the welfare and benefit of the Tribe and tribal Members; and
- WHEREAS, There is a continued need for donated Commodity Distribution Program on the Fort Berthold Reservation: and
- WHEREAS, The Commodity Distribution Program benefits eligible American Indian households in the communities of Watford City, Killdeer, Halliday, Beulah, Garrison, and Roseglen, North Dakota:
- WHEREAS, The Three Affiliated Tribes, Tribal Business Council through their Human Resources Department will continue to increase and improve their capabilities of providing more accessible and effective Health and Human Services: and
- WHEREAS, The Three Affiliated Tribes has, in the past, contracted for the operation of this program.
- NOW, THEREFORE IT BE RESOLVED, that the Tribal Business Council desires to recontract with the State Department of Public Instruction, U.S. Department of Agriculture for continued Commodity Services operation: and
- BE IT FURTHER RESOLVED, that the Three Affiliated Tribes requests that \$149,405.00 be granted for this purpose.
