THREE AFFILIATED TRIBES

- WHEREAS, the Three Affiliated Tribes is an unincorporated tribe of Indians having accepted the Indian Reorganization, June 18, 1934, and the recognized governing body of the Tribe is known as the Three Affiliated Tribal Council; and
- WHEREAS, the Three Affiliated Tribal Council, Pursuant of the Constitution of the Three Affiliated Tribal Council, is empowered to negotiate with the Federal, State and Local agencies in the matters which affect the Three Affiliated Tribes, and is empowered to promote and protect the Health, Education, and general Welfare of the tribe and its members; and
- WHEREAS, the Tribal Council recognizes the need for proper food service and sanitation practices where ever food and drinks are served; and
- WHEREAS, there are permanent food service facilities, and it is custom for various individuals, clubs, firms, associations and organizations to engage in the serving of food and drinks at the various tribal functions, celebrations, pow-wows and events: and
- WHEREAS, the Food and Drug Administration (FDA) 1997 Food Code is the Nationally recognized standard for compliance responsibilities for food service, retail food stores, or food vending operations; and consists of model requirements for safeguarding public health and ensuring food is unadulterated and honestly presented when offered to the consumer; and
- WHEREAS, the FDA 1997 Food Code, is the latest and best scientifically based food safety advice for those responsible for regulating retail establishments, having been revised and reviewed by the FDA, Center for Disease Control (CDC), United States Department of Agriculture (USDA), and notably the Conference for Food Protection (CFP) and the Association of Food and Drug Officials (AFDO).
- NOW THEREFORE BE IT RESOLVED, the Three Affiliated Tribal Council recognizes the importance of the latest "state of the art" model in Food Safety and fully supports the adoption of the 1997 FDA Food Code, for use of all applied entities in food service within the jurisdiction of the Three Affiliated Tribes; and
- BE IT FURTHER RESOLVED, that the Chairman, Russell Mason SR., and the Secretary, Daylon Spotted Bear, are hereby authorized and instructed to sign this resolution for and behalf of the Three Affiliated Tribes.
