## RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

- WHEREAS, This nation having accepted the Indian Reorganization Act of June 13, 1934, and the authority under said Act; and
- WHEREAS, This Constitution of the Three Affiliated Tribes generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of the Tribes and of the enrolled members thereof; and
- WHEREAS, The Congress has recognized that the history of past educational policies of the United States toward the Mandan, Hidatsa and Arikara tribal languages has resulted in a dramatic decrease in the knowledge and use of the fundamental cultural practice amongst the Three Affiliated Tribes enrolled membership; and
- WHEREAS, The Fort Berthold Community College must work hand-in-hand with the Three affiliated Tribes to continue our own community based language restoration programs; developing approaches and methods of the tribal teaching of our native languages in assuring the survival and continuing vitality of the Mandan, Hidatsa and Arikara languages; and
- WHEREAS, The Three Affiliated Tribes recognizes that it is the responsibility of the educational leadership of the tribal college to develop our own language plans, technical capabilities, and access to the necessary financial and technical resources in order to assure the survival and continuing vitality of the Mandan, Hidatsa and Arikara languages.
- NOW, THEREFORE, BE IT RESOLVED, that The Tribal Business Council fully supports this critical tribal educational goal and will provide support through a line item of the Economic Recovery Fund distribution.
- NOW, THEREFORE, BE IT RESOLVED, that the Three Affiliated Tribes of the Fort Berthold Indian Reservation hereby authorizes the Fort Berthold Community College to submit a Language Grant application to the Administration for Native Americans on our behalf.
