

**RESOLUTION OF THE GOVERNING BODY OF THE
THREE AFFILIATED TRIBES OF THE
FORT BERTHOLD RESERVATION**

WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and

WHEREAS, The Constitution of the Three Affiliated Tribes generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the best interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and

WHEREAS, Article VI, Section 5 (c), of the Three Affiliated Tribes Constitution, specifically grants the Tribal Business Council power to administer any funds or property within the exclusive control of the Tribes to make expenditures from available Tribal funds for public purposes of the Tribes; including salaries or other remuneration of Tribal officials or employees; and

WHEREAS, All expenditures from said fund shall be by resolution duly passed by the Tribal Business Council to such effect; and

WHEREAS, The Tribal Business Council is mandated to approve the Fiscal Year 1999 (October 1, 1998 – September 30, 1999), Tribal Operating Budget;

NOW, THEREFORE, BE IT RESOLVED, That the Three Affiliated Tribes Business Council has reviewed and hereby approves the Three Affiliated Tribes General Fund Budget and Revenues for Fiscal Year 1999 in the Amount of \$7,271,542- Revenue and \$7,270,280-Expenditures and in accordance with the attached documents:

1. Three Affiliated Tribes Tribal Business Council Fiscal Year 1999 General Fund Budget;
2. Three Affiliated Tribes Tribal Business Council Salary Budget for Fiscal Year 1999;
3. Exhibit A – Three Affiliated Tribes Tribal Program Budgets for Fiscal Year 1999;
4. Exhibit B – Three Affiliated Tribes Tribal Enterprises for Fiscal Year 1999;
5. Exhibit C – Three Affiliated Tribes Docket Programs for Fiscal Year 1999;
6. Exhibit D – Three Affiliated Tribes Docket Reserve Programs for Fiscal Year 1999;

7. Exhibit E – Three Affiliated Tribes Liabilities to be Retired for Fiscal Year 1999;
8. Exhibit F – Three Affiliated Tribes Long Term Debt for Fiscal Year 1999.
