RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD RESERVATION

- **WHEREAS,** This Nation haaving accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act; and
- WHEREAS, The Constitution of the Three Affiliated Tribes generally authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS, Article VI, Section 5 C of the Constitution of the Three Affiliated Tribes specifically authorizes and empowers the Tribal Business Council to administer the funds within the exclusive control of the Tribes and to make expenditures from available Tribal funds for the public purposes of the Tribes; and
- **WHEREAS,** It is in the best interest and welfare of the Tribes to promote economic development and opportunities for enrolled members on or off the Reservation; and
- WHEREAS, Jody L. Hale-Brieck, an enrolled member of the Mandan tribe of the Three Affiliated Tribes, now residing at 4092 Concord Drive, Elizabeth, PA., 15037, is requesting a business development loan in the amount of \$6000.00.; and
- WHEREAS, The Tribal Business Council requires that previous to the release of any Tribal funds for the purpose of assisting individual tribal member's economic or business development proposals, such proposals shall be financially sound and valid; and
- WHEREAS, Enrolled member, Jody l. Brieck, has provided a valid and financially sound business development proposal for business development off the Reservation and seeks financial support and assistance from the Three Affiliated Tribes to complete her proposal for development in the bakery business; and

BE IT FINALLY RESOLVED, The Tribal Business Council hereby authorizes the release of Tribal funds in the amount of \$3000.00 in the form of a grant and \$3000.00 in the form of a loan with a 8.25% APR, \$20.62 per month for first 6 months, thereafter, 260.32 beginning 12-01-99, until paid in full for the loan with secured collateral as 77 acres of patent fee land owned by Edward Hale provided that all documents are in place.
