- WHEREAS, The Constitution of the Three Affiliated Tribes generally authorized and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS, The Natural Resources Committee of the Tribal Business Council approved the purchase of the land described below; and
- WHEREAS, It has been determined that it is in the best interest of the Tribe to acquire the land; and
- NOW, THEREFORE, BE IT RESOLVED, The Three Affiliated Tribes' Tribal Business Council approved the purchase of land from:

## Laura L. White Owl, 301-U4562

For a cash consideration of \$15,000.00 which is the Negotiated Value, utilizing funds from the Docket 350-G Land Purchase Account and hereby authorized the Chairman of the Tribal Business Council, It's Secretary, and the Superintendent of the Fort Berthold Agency, the Area Director, and the Commissioner of Indian Affairs to prepare all documents and to do all things necessary to transfer title of the land to the United States of America in trust for the Three Affiliated Tribes of the Fort Berthold Indian Reservation, to wit:

Allotment 551A-A, E1/2NE1/4NW1/4NW1/4 Section 33, T. 152 N., R. 94 W., containing 5.00 acres, more or less, valued at \$15,000.00.
