NOTICE TO VOTERS
**PROCEDURE TO CONTEST THE NOVEMBER 4, 2014 GENERAL
ELECTION**

Pursuant to Part IX, Section 1 of the Election Ordinance of the Three Affiliated Tribes, a defeated candidate or ten (10) qualified Tribal voters may contest the November 4, 2014 General Election within a period of three (3) days from the date on which the election results were certified by the Tribal Election Board. The date of such certification is November 4, 2014. Any such election contest shall be filed with the Tribal Election Board, within the prescribed time period, by delivering a duly verified written election contest complaint, whether by mail or by hand, to the office of the Tribal Election Board in the Tribal Administration Building, in New Town, The filing of the written complaint must be accompanied by a nonrefundable filing fee in the amount of \$500 Hundred and 00/100 Dollars (\$500.00).
