***NOTICE TO VOTERS  
PROCEDURE TO CONTEST THE SEPTEMBER 20, 2016 PRIMARY***

Pursuant to Part X, Section 1 of the Election Ordinance of the Three Affiliated Tribes, a defeated candidate or ten (10) qualified Tribal voters may contest the September 20, 2016 Primary Election within a period of three (3) days from the date on which the election results were certified by the Tribal Election Board. The date of such certification is September 23, 2016. Any such election contest shall be filed with the Tribal Election Board, within the prescribed time period, by delivering a duly verified written election contest complaint, whether by mail or by hand, to the office of the Tribal Election Board in the Tribal Administration Building, in New Town. The filing of the written complaint must be accompanied by a nonrefundable filing fee in the amount of Two Hundred and 00/100 Dollars (\$100.00).
