

## RESOLUTION OF THE GOVERNING BODY OF THE THREE AFFILIATED TRIBES OF THE FORT BERTHOLD INDIAN RESERVATION

A Resolution Entitled, "Directive to the Three Affiliated Tribes to Make Available Funds for Withdrawal from the East Segment of the Three Affiliated Tribes Account #333-56130 in the Amount of \$1,000,000.00 for the White Shield Segment Project with Dakota Territory Custom Homes."

- WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act and having adopted a Constitution and By-laws pursuant to said Act; and
- WHEREAS, Article III of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council is the governing body of the Tribes; and
- **WHEREAS,** The Constitution of the Three Affiliated Tribes authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the Tribes and of the enrolled members thereof; and
- WHEREAS, Article VI, Section 5 (1) of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council has the power to adopt resolutions regulating the procedure of the Tribal Business Council and other Tribal agencies and Tribal officials on the Reservation; and
- WHEREAS, Article VI, Section 5(c) of the Constitution of the Three Affiliated Tribes specifically authorizes and empowers the Tribal Business Council to administer funds within the exclusive control of the Tribes and to make expenditures from available Tribal funds for public purposes of the Tribes; and
- **NOW, THEREFORE BE IT RESOLVED**, the Tribal Business Council hereby authorizes the draw down amount of \$1,000,000 out of the Three Affiliated Tribes East Segment account #333-56130 to pay for the contract with Dakota Territory Custom Homes for the construction of homes in the East Segment of the Three Affiliated Tribes.
